

**TRANSFORM SR BRANDS LLC SERVICES PROMOTION**  
**MINNESOTA VIKINGS x KENMORE FRIDGE SWEEPSTAKES OFFICIAL RULES**

NO PURCHASE OR PAYMENT OF ANY KIND IS NECESSARY TO ENTER OR WIN. PURCHASE OR PAYMENT WILL NOT INCREASE YOUR CHANCES OF WINNING. Void in Alaska, Florida, New York, Hawaii, Rhode Island, where prohibited by law, and outside the United States. Subject to all federal, state, and local laws, regulations, and ordinances.

3. **Entry Period.** The Sweepstakes Entry Period shall be December 30, 2025 at 12:00 am ET continuing through February 06, 2026 11:59 pm ET.

Sponsor's computer is the official time keeping device for this Promotion.

Internet access, phone, and usage charges imposed by your online or mobile service provider(s) may apply.

Upon completion and submission of Entry Form, Entrant will receive one (1) entry ("**Entry**") into the applicable Sweepstakes. Entries must be submitted by Entrant. Automated or bulk Entries or Entries submitted by third parties will be disqualified. Proof of sending or submission of Entry will not be deemed proof of receipt by Sponsor. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.
